

## Kensington Digital Media/24/7 Cars Summer Car Giveaway - 2025

1. From June 20th 2025 - July 18th, 2025, listeners will be given opportunities to sign up at station events to register to win. There are numerous ways to win a ticket. These methods may include on the air, online, in person or by other methods to be determined at any time by Kensington Digital Media of Indiana. No method guarantees a winner and methods of winning can be changed at any notice without warning. All hopeful entrants must have a mobile device capable of texting to enter this contest. Each mobile phone number may only enter the contest one time per entry method as announced on 107.3 WRSW, Willie 103.5, or at [1073wrsww.com](http://1073wrsww.com) and [willie1035.com](http://willie1035.com).
2. Winners are eligible to win the contest once per calendar year and are responsible for any applicable taxes associated with winning the prize. Winners will be required to complete a federal 1099 tax form supplied by either Kensington Digital Media (WRSW) or sponsor associated with the prize. Winners may be required to provide Kensington Digital Media or sponsor associated with the prize with their driver's license number and/or their social security number. Any applicable taxes are solely the responsibility of the winner.
3. The grand prize from 24/7 Cars will be announced in detail on Friday, June 13th on both WRSW and WAWC. The winner of the aforementioned grand prize will be responsible for any and all taxes, documentation and issued an IRS form #1099. The winner may also choose to accept a cash option instead, with an exact amount to be determined by 24/7 Cars. Accompanying IRS form #1099 will be issued in lieu of accepting the aforementioned grand prize.
